4. Electronic Bids must be submitted to the Department of Health Services, Management Division, Teku, Kathmandu, Nepal through <https://bolpatra.gov.np/egp> on or before **12:00 Hour** on **27-Feb-2020**.

Bids shall be opened in presence of Bidders' representatives who choose to attend on **13:00 Hour** on **27-Feb-2020** at the office of Department of Health Services, Management Division, Teku, Kathmandu, Nepal. Bids must be valid for a period of **90 days** after the day of bid opening and must be accompanied by bid security as mentioned above or the equivalent in a freely convertible foreign currency. The Bid Security shall be in the name of the Bidder and in the case of a Bid Security issued by a foreign bank, the same shall be counter-guaranteed by a Class "A" Commercial Bank in Nepal. The Bid Security must be valid for thirty (30) days beyond the bid validity period as mentioned above (**i.e. valid upto 26 June, 2020**).
6. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
7. In the case of discrepancies or error in bid documents, bid notice or any other document, the DOHS reserves the right to amend and correct at any time.
