7. Electronic bids must be submitted to the Department of Health Services, Management Division through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 on **February- 12, 2020**.

Bids shall be opened in the presence of Bidders' representatives who choose to attend at **13:00 hour (Local time) on February 12, 2020**, at the office of Department of Health Services, Management Division. Bids must be valid for a period of **90 days** counting from the day of bid opening. All bids must be accompanied by bid security not less than **NPR 220,000.00**, which shall be valid for minimum 30 days beyond the bid validity period (**i.e. valid upto June 11, 2020**).
6. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
