Bids shall be opened in presence of Bidders' representatives who choose to attend on **13:00 Hour** on **15-December-2019** at the office of Department of Health Services, Management Division, Teku, Kathmandu, Nepal. Bids must be valid for a period as mentioned above after the day of bid opening and must be accompanied by bid security as mentioned above or an equivalent amount in a freely convertible foreign currency, which shall be valid for thirty (30) days beyond the bid validity period as mentioned above date.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
