Bids shall be opened in presence of Bidders' representatives who choose to attend on 13:00 Hour on 20 February 2018 at the office of Department of Health Services, Logistics Management Division, Teku, Kathmandu, Nepal. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of NPR. 2,000,000.00 or the equivalent in a freely convertible foreign currency. The Bid Security shall be in the name of the Bidder and in the case of a Bid Security issued by a foreign bank, the same shall be counter-guaranteed by a Class "A" Commercial Bank in Nepal.
